Women in Leadership Development (WILD) is a program for emerging female leaders who want to enhance their influence and impact (refer to the program brochure available at www.peoplemeasures.com.au/wild).

Scholarship recipients will pay a nominal \$500 (excl. GST), for the full program. This represents a substantial subsidy for the program (full price program \$4,450 excl. GST or \$3,450 excl. GST for individuals from not-for-profit organisations).

The program runs from August 2022 to November 2022.
